# Report of the Chairman on the work of the Overview and Scrutiny Committee

This report gives an overview of the issues considered at the 7 July 2015 meeting.

## 1. Fundamentals of Overview and Scrutiny

1.1 The Committee received a training session facilitated by Ann Reeder, an expert advisor and regional advocate for the south of England with the Centre for Public Scrutiny. The session gave an outline of what Overview and Scrutiny is, how it works and what it can achieve.
