RECOMMENDATIONS OF THE EXECUTIVE

1. SPELTHORNE BEST VALUE PERFORMANCE PLAN (BVPP) 2002/2003 – KEY DECISION

1.1 The Executive has considered a report on a draft of the Council's Best Value Performance Plan (BVPP) for 2002/2003. There were two major changes affecting the preparation of the Plan for 2002/2003, firstly the revised statutory BVPP publication date of 30th June 2002 and secondly the alignment of the BVPP with the Council's Community Strategy by the changing of the priorities for the Council within the section entitled "What are we aiming for?"

1.2 The Executive recommend that:

The key priorities for the Council listed in the Best Value Performance Plan 2002/2003 be endorsed and that the Council agree to the adoption of the BVPP as presented.

2. IMPLEMENTATION OF NEW POLLING DISTRICT ARRANGEMENTS – KEY DECISION

2.1 The Executive has considered two separate reports on the options for the new Polling Places to be introduced within the Borough of Spelthorne in May 2003. The original report dealt with proposals for new Polling Places for the whole Borough, and the further report requested by the Executive dealt more specifically with those Polling Places proposed for the Staines Ward (Polling Districts S2 and S3), the Sunbury Common Ward (Polling District SC), the Sunbury East Ward (Polling Districts SE2 and SE3) and the Halliford and Sunbury West Ward (Polling District HSW3. Members of the Executive agreed that maximum publicity would be given to all the new polling arrangements for Spelthorne, including an article in the Borough Bulletin.

2.2 The Executive recommend that the Council:

Approve the designation of the Polling Districts and Polling Places for the Borough, as set out in the Chief Executive's original report to the Executive on 16th April 2002 and as detailed below, subject to arrangements being made by the Director of Community Services to allocate parking free of charge at the Riverside Car Park for those electors voting at the new Staines Community Centre in Polling District S2.
