"We, the Mayor and Councillors of the Borough of Spelthorne, in pursuance of Section 249 (5) of the Local Government Act, 1972, do confer the Title of Honorary Freeman of the Borough of Spelthorne upon **GERALD CEASER, FRICS, MBEng** in recognition of the eminent service rendered by him to the Borough and to the Council.

His eminent voluntary service to the local community for over 30 years, includes Governor of Bishop Wand School since 1974, setting up and serving on local and South East Regional sports bodies, in particular Surrey Sport and Surrey Youth Games, his contribution to the welfare of young people as Trustee of the National Association of Clubs for Young People and Chairman of the Middlesex Young Peoples Clubs and his drive in setting up local Charity events like the Mayor's Fun Day and Sunbury's Picnic in the Park.
