105/12 Minutes

107/12 Announcements from the Mayor

The Mayor announced that the Mayor's Civic Reception will be held on 17 May at the Orangery, Shepperton Studios at 7.30pm.

108/12 Announcements from the Leader

The Leader announced that Spelthorne Borough Council had received a silver and bronze in this year's National Improvement and Efficiency Awards. The silver award was presented in the 'Connecting People' category, and the bid also gained bronze in the 'Council of the Year' category. The Leader congratulated and commended the key partners who helped Spelthorne achieve these awards. 110/12 Questions from members of the public

One question was submitted under Standing Order 13 by a member of the public, Mr. Bernie Spoor.

Mr. Bernie Spoor asked the following question to the Council:

"Given that we are now officially facing a drought, which will result in exceedingly dry grasses and vegetation, has a risk assessment for fire been undertaken on the parks which have uncut margins, especially where they come up against residents' fences, adjacent car parking or unfenced roads?

This is not a light-hearted question as the result of a long period of exceedingly dry weather on long dried-out and highly inflammable vegetation and grasses close to residential and pedestrian areas is dangerous and therefore of great concern."

The response from Councillor R.L. Watts at the meeting is set out below:

"Thank you for your question, Mr. Spoor.

The Council is currently carrying out a review of all its Fire Risk Assessments. This includes the Council's Parks and Open Spaces and particular attention will be given to uncut grass and vegetation which is close to other properties."

111/12 Recommendations of the Cabinet

(b) Such panel to have representation from each council as is appropriate with numbers and representatives to be determined by the Head of Corporate Governance in consultation with the Leader, but to be broadly representative of the political make-up of the councils involved.

The Council considered the recommendation of the Cabinet on the proposal to set up a joint committee with the other Surrey authorities as the Police and Crime Panel covering the area of the Surrey Police Force.

RESOLVED that Council:

a) agrees to the establishment of the joint committee, with the other Surrey local authorities, to act as the Police & Crime Panel in Surrey (in accordance with the Police Reform and Social Responsibility Act 2011) and

b) nominates Councillor P. C. Forbes-Forsyth as the Council's representative on the Panel.
