Reason for Recommendation	The current Service Level Agreement (SLA) for this service expires at the end of March 2022.		

1. Key issues

- 1.1 In April 2021, the Council commenced a partnership Step-Down Service. It was commissioned on behalf of the North West Surrey Health Alliance Board, to deliver practical benefits to healthcare service, working together with partner organisations. The organisations (partners) who deliver the service are Spelthorne Borough Council, A2Dominion, Elmbridge Borough Council, Runnymede Borough Council, The Whitely Homes Trust, Woking Borough Council. Spelthorne are the Lead authority.
- 1.2The aim of the service is to provide up to six-weeks short term accommodation for people who require some additional support on discharge from hospital, prior to moving into their own accommodation, or who are identified in the community as requiring a "step-up" accommodation to prevent hospital admission.
- 1.3 The step-down accommodation for this service is furnished, prepared, and managed by Spelthorne Borough Council (SBC). The funding for this service is provided by The Alliance and managed by SBC, who is responsible for ensuring that the funding is used appropriately. We have 7 properties across Surrey for this service. The properties remain in ownership of the partners and we have a service level agreement, which detail the relationship. In the budget year 2021/22 the funding provided for this service was £299,700. This was designed to cover the rent, council tax and utility charges for the flats, as

well as to cover the cost of staff to administer the scheme, cost of meals, furnishing, cleaning and other expenses as deemed appropriate to support residents as part of this project.

1.4The current agreement for this service end on 31 March 2022, we propose to extend the agreement for a further period of twelve months to continue the service.

2. Options analysis and proposal

Option 1: Not to agree the proposed extension of the Service

The service would end at the end of March 2022 if this option is chosen. This would add additional pressure to the healthcare system, in particular hospitals.

Option 2: To approve proposed extension of the service (recommended)

Discussions with North West Surrey Health Board would commence with a view to extend the service and partnership agreement, with associated funding for a further year. This option would be fully paid by the NW Surrey Alliance Board, not by Spelthorne Borough Council.

3. Financial implications

- 3.1 The service is fully funded by North West Surrey Health Alliance and managed by SBC. There is no cost to Spelthorne Borough Council.
- 3.2 Although full budgetary requirements will be assessed at the end of the financial year, we are already identifying savings that can be made as part of the service delivery. We estimate that the project can be delivered within a reduced budget of £235,000 in 2022/23. The funding request will be made to the Alliance Board in January 2022.

4. Other considerations

4.1 The project has been a success and provided much needed accommodation to many residents leaving hospital. Since 1st April 2021 the service had:

Quarter 1

24 referrals

14 accepted and accommodated

Quarter 2

26 referrals

13 accepted and accommodated

Total to date

50 referrals (referrals need to be carefully assessed for meeting the criteria both of the residents and the facilities)

27 accepted and accommodated

We anticipate by the end of the first year there will be between 50-60 residents assisted.

Average length of stay is approx. 38 days.

4.3We strive to continually improve our service and we recognise the areas of the service that work well and the areas that we would like to work to improve. Those are as follows:

What works well

- Supporting Hospital discharges
- Reducing bed blocking
- Supporting vulnerable residents to safely return home
- Supporting residents to further rehab/reable in an environment with onsite care
- Enabling residents to see an alternative option from their home environment
- Ensuring residents own homes are safe to return to, often issues such as; No heating, No electricity, No Hot water, Hoarded, Pest infestation can be resolved whilst residents are in "step down accommodation".

Areas to improve

- Turnaround of the scheme ready to re-use (cleaning of the flat)
- Quality of the information about the patient for the discharge
- Confirmation of acceptance in a scheme due to care staff availability and rotas
- Hospital transport delays
- Temporary GP registrations

Step 2 – What does the information you have collected, or that you have available, tell you?

What evidence/data already exists about the service and its users? General Spelthorne context

Almost half of Surrey's 20 most deprived super output areas are in Spelthorne. Three are in the ward of Stanwell North, two in Ashford North and Stanwell South and one in each of Ashford East and Sunbury Common. Spelthorne has the highest number of lone parent families and the highest level of child poverty in Surrey; it also has the highest under-18 conception rate in the county. That said, residents are largely healthy, with life expectancy for both males and females slightly above the national average.

Although the number of VAT and/or PAYE-registered business has fallen slightly over the past four years, Spelthorne has a low rate of unemployment: 1.4% of those economically active aged 16 to 64, compared to the South East (2.2%) and UK as a whole (3.5%). Heathrow Airport is a significant local employer, with 8.3% of Spelthorne's working population employed there. Significantly, 21.5% of those in work in Stanwell North are in low level employment compared to an average of 11.6% in Surrey. Average wages are slightly above regional averages at £630 per week for full-time employees.

Whilst house prices remain well above the national average, most residents are owner-occupiers (73%), followed by private rented (13%) and social rented (12%).

Gender / gender identity

Census data from 2011 shows that 50.5% of residents in Spelthorne were female, with the remaning 49.5% being male. There is no data known to be held in relation of other gender identities.

A White Paper published in December 2018 (Help shape our future: the 2021 Census of population and housing in England and Wales) sets out the Office for National Statistics' (ONS) recommendations for what the census should contain and how it should operate. The White Paper recommends that the census in 2021 includes a question about gender identity, asking respondents whether their gender is the same as the sex they were registered as at birth. The question will be separate from the question about sex (i.e., whether the respondent is male or female), which will be phrased in the same way as previous years. There is currently no official data about the size of the transgender population (the word 'transgender' is used here to describe people whose gender identity does not match the sex they were assigned at birth). The Government Equalities Office (GEO) has said that there may be 200,000 to 500,000 transgender people in the UK, but stresses that we don't know the true population because of the lack of robust data. The ONS has identified user need for official estimates in order to support policy-making and monitor equality duties.

Age

Spelthorne has a slightly lower population of under-30s (34%) compared to the rest of the country (37%), and a slightly higher population of 30-69 year olds (42%) compared with the UK average of (40%), The number of 70+ is 23%, which is broadly in line with the rest of the UK (24%). Disability

As of July 2019 there were around 2,020 PIP claimants in Spelthorne constituency. In comparison, there was an average of 2,500 claimants per constituency across the South East. Within Spelthorne, psychiatric disorders were the most common reason for claiming PIP. They accounted for 37% of awards, compared to 36% in Great Britain. 'Psychiatric disorders' include anxiety and depression, learning disabilities and autism. The second most common reason for awards was musculoskeletal disease (general), which accounted for 17% of awards within the constituency and 21% in Great Britain. Musculoskeletal disease (general) includes osteoarthritis, inflammatory arthritis and chronic pain syndromes. Source:

Sexual orientation

There is no accurate dataset which can be used to reflect solely Spelthorne. The White Paper recommends asking a new question about sexual orientation. The ONS has identified a user need for better data on sexual orientation – particularly for small areas – to inform policy-making and service provision, as well as monitoring equality duties. The ONS has previously used the Annual Population Survey (APS) to estimate the size of the lesbian, gay and bisexual (LGB) population in the UK. According to these estimates, just over 1 million people identified as LGB in 2016 (around 2% of the population). However, the sample population used in the APS isn't big enough to provide robust estimates of the LGB population in smaller areas.


