5. Subject to recommendation 3, note the Spelthorne Local Plan

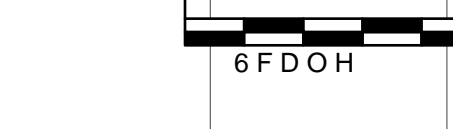
