## 1. Key issues

- 1.1 Following Council's agreement in October 2020 to progress with the change in governance arrangements to the Committee System, a Working Group consisting of the leaders of all political groups was established.
- 1.2 The Working Group met regularly between November 2020 and March 2021 to work collaboratively on the design and structure of the Council's proposed model for decision-making, which was implemented from the Annual Council meeting 2021.
- 1.3 At its meeting on 17 February 2020, the Working Group agreed it should continue to meet periodically to evaluate the success of the new arrangements and review how they are working in practice, with a full and formal review taking place after 12 months.

## 2. Options analysis and proposal

2.1 It is proposed that the Committee System Working Group is established for 2021-22 with the membership and remit as follows:

#### Membership

All group leaders of the political groups that make up the Council at any time the Working Group meets
