Just to let you know we have received 2 representations regarding your application for a new premises licence. As a result, we will now need to arrange a licensing sub committee hearing for your application to be determined. - Please remember that the blue notice poster needs to be visible 24/7 and cannot be covered by shutters.
- Please find attached the conditions we have proposed to go on your licence. please can you confirm that you are in agreement as I have changed the last one as you said children under 13 would need to be accompanied by an adult. Please note these will become legally enforceable conditions if your licence is granted.
- Please note late night refreshment is the sale of hot food and drink between 11pm-5am, so you will be unable to do this as you have not applied for this.
