### **Ongoing Community Work**

# **CONSTRUCTION PROGRESS – SOUTH**

### **Progress Update**

- First phase of tree planting complete
- · Major earthworks complete
- Piling commenced
- · Full site compound established
- Formation of car parks and internal roads underway

#### 3 Month Outlook

- · Steelwork erection
- Continuation of piling
- Construction of internal roads

### **Longer Term Programme**

• Completion from summer 2023



# **LANDSCAPING - NORTHWEST**

- Bunds have been formed and initial phase of planting completed.
- Planting establishing well and will be subject to ongoing maintenance and weed control.
- Additional planting to begin in November 2022 next planting season.





# **LANDSCAPING - SOUTH**

- Bunds have been formed and planted, following discussions with residents.
- Weed control, mulching, guarding and maintenance ongoing (including watering).
- Some plant failures have been reported (given the very dry spring), these will replaced in the next planting season.

## **OFFSITE HIGHWAYS WORKS**

### **Laleham Crossing and Village Gates**

- Village Gates design approved in principle by Surrey County Council (SCC) – awaiting final technical approval.
- Feedback on crossing designs in relation to on-street parking noted
   we are exploring alternative designs with SCC and consulting with relevant parties.
- Legal agreement with SCC to be finalised imminently following technical approval.
- · Road space booking to be amended with SCC accordingly.
- Forecast 4-week construction period contractor ready to start.

### **Charlton Crossing**

- · Existing gates have been refreshed.
- Outline designs of alternative crossing location with SCC.

#### **Other Off-Site Highways Works**

- Studios Road Roundabout technical approval issued by SCC 25 May 2022, legal agreement to follow.
- Spelthorne Lane Signals technical approval imminent from SCC



## **OFFSITE UTILITIES**


### **Progress and Programme**

- Works continue to the offsite power connections.
- Works to Laleham Rd to complete in early June 2022.
- Works will then continue along Ferry Lane and Thames Side.
- Overall completion to all offsite power connection works anticipated October 2022.

### **Live Planning Applications**

· Condition discharge applications across the site

### **Anticipated Future Planning Applications**

- Non-material amendments
  - · Additional landscaping around utility building
  - Minor changes to planting schedule due to availability
  - Minor changes to stage door locations
  - Security barriers and booths
- Amendments to multi-storey car park (South)
  - Revisions to layout based on contractor design
  - Façade / cladding
- Decked car park (North)
  - We have outline planning approval for decked car park – likely ground plus 2 floors
  - · Need for short term parking solutions
- Phone mast relocations
  - Applications to be submitted by mast operators
