Addendum to Application, dated 7th October 2022, made by Environmental Health, to Review the Premises Licence issued under the Licensing Act 2004, in respect of the premises, know as Vegan Pind 21B Clarence Street, Staines upon Thames, Surrey, TW18 4SU.

Following on from the application, made by Environmental Health to have the Premises License reviewed. Environmental Health have been involved with the premises, know as Vegan Pind 21B Clarence Street, Staines Upon Thames, Surrey.

Since the application for the review was made, Environmental Health have still been receiving complaints about loud music coming from the premises and also regulated entertainment after permitted hours. The complainants relate to:

1. Loud Music, especially from the bass when there is a Drum and Bass night.

- 2. Balcony being used after permitted hours, i.e. after 23:00, when it should be closed, with the door locked leading onto the balcony.
- 3. The number of customers exceeding the permitted number of persons, who can use the balcony at any one time.
- 4. Regulated entertainment music heard after the permitted hours as required by the Premises Licence, after 01:30.

5. When Environmental Health, were undertaking visits at nearby residential properties, the bass was an issue, due to the repetitive nature of the music being played. It was decided to reduce the level of the bass to reduce disturbance to nearby by residents. There was an exchange of emails, with the DPS, concerning the recalibration of the noise limiter, this was not arranged until the 25th November 2022. The DPS said they could make after 13:00, the final appointment was made for 14:00. However, when we arrived at the

premises. The DPS, was not present and the manager informed us that he would not be there until the evening. The level of the noise limiter was adjusted, with someone in a nearby residential premises. The bass was reduced, however the level could not be locked, as the DPS was present. The manager was advised to keep it at that level.

6. On the 26th November 2022, an out of hours visit, was undertaken at 22:53, could hear the thud/thud of the bass. It appeared that the level of the bass was at the level it was prior to the adjustment undertaken to the noise limiter on the 25th November 2022.
