New evidence to considered by sub-committee from the Licensing Authority

The Licensing Authority has submitted a representation in support of the recommended revocation of the Premises Licence by the Environmental Health Authority for Vegan Pind Ltd at the premises known as Vegan Pind.

Since the representation was submitted the Licensing Authority has received the below complaints from the Environmental Health team covering 3 weekends:

20 November at 02.04 report to	Complainant advised music stopped as of 2am.
out of hours team	
25 November 2022 at 21.30 report to out of hours team	Six customers had been standing on the outside balcony talking loudly & believed that the maximum number permitted is five. They said that they were on the balcony for 20 minutes before going back inside. Also wanted to inform the case officer that the music continued last weekend until 0158 hours on Sunday 20/11/22 & the restaurant should've been closed by 0130. Further call received from the call centre to contact complainant. Informed me that the music was turned off at 0136 hours but then turned back on again at 0145 hours. As we were speaking, the complainant confirmed that the music had stopped at 0159 hours.
04 December 2022 at 02:36hrs report to out of hours team	People still inside restaurant and loud music.

The Licensing Authority has requested CCTV and SIA door supervisor book on multiple occasions but this has not been forthcoming, despite giving a deadline which was exceeded. Please find at the end of this document the email exchange.

The Premises Licence has the below condition in respect of CCTV:

24.: Viewing of recordings shall be made available immediately upon the request of Police or authorised officer of the Council.

Complaints about the noise and breaches of licensing conditions and licensable hours are still being received. The Licensing Authority are extremely concerned that the licensing objectives are not being upheld, there is a lack of cooperation with the Licensing Authority. The Licensing Authority has not been able to investigate the complaints as the CCTV requests have been forthcoming. Mr Dhunay has stated that he needed to get a new cable,

however, this was some time after the request for CCTV was made. In addition, Licensing Authority was under the impression that CCTV could be accessed on Mr Dhunay's mobile phone.

CCTV was finally received on the 1 December 2022; 3 emails of CCTV were received however one was a duplicate.

This did not include the full times that were asked for on the 20 November but did show the premises closing.

The Licensing Authority has replied to Mr Dhunay to request the CCTV for the most recent complaint from 4 December 2022 and to query regarding the duplicate footage. At this time, no reply has been received and no SIA books have been provided:

Its is unknown why the premises would be closing at 01:58hrs rather than 01:30hrs.
