	Adopt the Joint Enforcement Team – Environmental Crime Enforcement Policy at Appendix 1 of this report.
Reason for Recommendation	This new policy pulls together all Environmental Enforcement offences currently dealt with by JET officers and shows the levels of enforcement available and the relevant case disposal.

1. Summary of the report

1.1 This report seeks to ensure that this new Environmental Crime Enforcement Policy brings together all the various legislative acts, byelaws, and guidance (as can be seen from the background papers below) into one clear and concise policy. If this policy is adopted by committee, it will inform Spelthorne's residents and businesses of all the Environmental Offences that the Council's JET investigate and the penalties if offences are committed and detected.

2. Key issues

2.1 The Joint Enforcement Team came into operation in December 2014 prior to that there was little by way of any meaningful Neighbourhood Services enforcement. The JET team undertake many Environmental Crime investigations and prior to this proposed new policy there had not been one in place. Currently all investigations rely on various central government documents providing guidance on the investigation of various Environmental

crimes and the issuing of fixed penalty notices. This policy brings together all these strands in relation to Council responsibilities for the investigation of Environmental Crime, the investigations themselves, and the result of those investigations into one overarching document which if adopted and published can serve to inform the Council's residents of the Policy and what they can expect from it.

3. Options analysis and proposal

3.1 The following decision options are available for consideration by the Committee:

Option 1 Preferred option

The Neighbourhood Services and Enforcement Committee adopt the Policy which will allow the JET to operate a consistent approach to maintain a clean, safe environment and strengthen the Authority's approach to tackling Environmental crime within the borough of Spelthorne.

Option 2

The Committee do not adopt this Policy and the service will continue working from separate guidance policies provided by central Government for both environmental crime and ASB issues.

Option 1 is recommended for the following reasons:

The policy brings together all enforcement options for Environment Crime under one policy, to ensure a consistent approach in dealing with all Environmental Crime that the JET currently deal with.

4. Financial implications

4.1 There are no financial implications associated with delivering and managing the Environmental Crime Enforcement Policy.

5. Risk considerations

5.1 There are no risks associated with this policy. It is, however, important for the reputation of the Authority that the officers work from an up-to-date policy in line with current legislation and that is published on Spelthorne Borough Council's website.
